ST. MARY, STAR OF THE SEA SCHOOL AFTERCARE PROGRAM
AGREEMENT 2011-2012

The following constitutes an agreement between St. Mary, Star of the Sea School Aftercare Program and the undersigned, effective September 7th, 2011.

1. Fees:

Fees are payable by the Friday prior to each week. Children will not be able to participate in the program unless fees are paid. The fees stated below are for students of St. Mary, Star of the Sea School. Fees for the program are as follows:

1 child - \$80.00 per week
2 children - \$120.00 per week
3 children - \$145.00 per week
4 children - \$185.000 per week

Non-St. Mary's Students - \$85.00 per week per child

***To pick up a child at or after 6:30 p.m., add \$10.00 per child per week.

A week is defined as the number of days that school is in session. Some weeks may be three or four days long.

Per day fees will be charged at \$30.00 per student per day also payable on the Friday prior to the week the days are requested.

There will be no refunds for absences as staff will be in place for the number of children anticipated for that week or individual day.

2. Schedule:

The Aftercare Program will operate on Mondays, Tuesday, Thursdays, and Fridays from 3:00 p.m. until 6:00 p.m. On Wednesdays the program will be from 1:00 p.m. until 6:00 p.m. *****see note above regarding extra charge for 6:30 pickup.

On days when there is an 11:30 a.m. dismissal, such as on First Fridays, THERE WILL BE NO AFTERCARE PROGRAM.

There will be no aftercare on any day when school is not in session. There will be no aftercare program after June 14th, 2012.

“Children may also be dropped off “EARLY” from 7:00 a.m. – 7:30 a.m. for an additional fee of \$5.00 per child per day. This is a separate charge from the aftercare program and should be sent in an envelope marked with your child’s name and early drop off.

3. **Other Considerations:**

All rules and guidelines set forth in the Parent/Student Handbook will be followed. Continual unacceptable issues will result in your child’s removal from the program.

Children must be picked up by 6:00 p.m. There can be no exceptions to this rule unless specific arrangements are made with the director.

Children will be released only to those people listed below. If someone else must pick up your child, please notify the school in writing (if possible). Or be sure to call the school before the end of the school day.

If a child must be sent home on the bus, or will not be staying for aftercare, a note must be sent in advance.
